The Town of Clayton will receive sealed proposals for construction of Westfield Ridge Cul-de-Sac adjacent to the east end of Westfield Ridge in the Town of Clayton, Winnebago County, Wisconsin. Work will include constructing the cul-de-sac to gravel grade in 2019, and providing the first layer of asphalt on the roadway in 2020.

Bids will be received until **10:00 a.m. local time, August 15, 2019 at the Town of Clayton Town Hall, 8348 County Road T, Larsen, Wisconsin** at which time and place all proposals will be publicly opened and read aloud.

**Bids:** Proposals shall be prepared and submitted on the forms provided in the bid documents. All proposals shall be submitted in a sealed envelope labeled "Proposal – Westfield Ridge Cul-de-Sac, Town of Clayton". No proposal shall be accepted after 10:00 am on **August 15, 2019**.

**Bid Security/Withdrawal/Rejection:** No bid will be received unless accompanied by a certified check or bid bond equal to at least 5% but not more than 10% of the bid payable to the Town of Clayton as a guarantee that if the bid is accepted, the Bidder will execute and file the Contract, Performance and Payment Bonds, and Certificate of Insurance within fifteen days after the award of the Contract. If the successful Bidder so files the Contract, Bonds, and Certificate of Insurance, the Owner shall return the check or bond upon execution of the Contract. If the Bidder fails to file the Contract, Bonds, and Certificate of Insurance, the amount of the check or bid bond shall be forfeited to the Town of Clayton as liquidated damages.

No bid shall be withdrawn after the opening of the bids, without the consent of the Owner, for a period of sixty (60) days after the scheduled time for closing of the bids. The Owner reserves the right to reject any and all bids and to waive any informality in the bidding.
